#### Chairperson's report by Antony Young

HNZT Chairperson, Antony Young formally opened the Horowhenua New Zealand Trust AGM at 5:05pm and welcomed all those in attendance. The Chair noted the recent notice of resignation from Trustee Sarah Ryan who would be stepping down from the Trust following the AGM. The Chair thanked Sarah for her service as a Trustee.

The Trust was founded by members of the Economic Development Board wanting to make a difference in their community. The Trust's goals are to drive better economic and social outcomes in the Horowhenua, creating opportunities for all who live and work here, and helping Horowhenua grow. Trustees are always looking for what we can do to impact and support positive social outcomes in the community.

The Trust is now in its fourth year of operation, and we are proud to see the difference we have made – both through the work of the Trust's subsidiary the Horowhenua Company Limited, but also through our direct distributions back to the community. The Horowhenua Company Limited is wholly owned by the Trust and that company generates profits for re-investment in commercial initiatives and distributions that drive projects for social good.

A video was played to the audience recapping the 2021 – 22 year. The video highlighted work carried out by The Horowhenua Company Limited, and distributions made by the Trust to Hope Kete, Wahine Toa and the Mayoral Relief Fund.

The Chair thanked the staff at The Horowhenua Company Limited and the Trust's advisors for their efforts during the year. The Chair also acknowledged the leadership of Chief Executive Catriona McKay, and the company Board, Malcolm Alexander, Cam Lewis and Ron Turk.
